## Clean and Green Newsletter April – May 2024

Our teams from Cleansing and Parks and Green Spaces have been busy responding to <u>reports</u>. These reports relate to overgrown vegetation, cleaning of road signs, weeding, sweeping and litter picking. In March and April, we have responded to and resolved 882 reports which our teams have worked hard to fix.

Keeping our streets clean and green is essential for a vibrant and healthy community. Here are some ways we can work together to achieve this.

Our Cleansing teams have been also carrying out annual verge clearance this has resulted in **246 bags** being filled removing **738kg** of litter from the verges right across Bath and North East Somerset.

The Report It pages on the website allows residents and business owners to report local problems such as graffiti, fly-tipping, broken paving slabs, or malfunctioning street lighting. Simply enter your nearby UK postcode or street name, locate the issue on a map, and provide details. This will make sure your report is sent promptly to the correct team.

**Community Involvement**: Have you considered participating in community clean-up events? Organise neighbourhood <u>litter picks</u>, tree planting drives, or flowerbed maintenance. When we all pitch in, our streets become cleaner, greener, and more inviting.

#### **Environmental Enforcement**

In February, the team issued **65** fixed penalty notices related to commercial waste, littering and flytipping and the escape of controlled waste. Environmental Enforcement can catch offenders not disposing of waste properly and permitting dog fouling in public areas.

### Highway Maintenance and Drainage

Highway services continue to carry out gully cleansing action to maintain our drainage network to keep it running efficiently and to help prevent flooding. In March, the team inspected **1686** gullies of which **1484** were cleaned and April a further **2176** were inspected of which **2095** were resolved, the team continued to battle the elements with the prolonged wet weather, resulting in higher operational demands.

#### **Recycling Centre Changes**

In March we introduced some changes to improved recycling performance at our recycling centres. Anyone visiting a recycling centre to dispose of bags of mixed general waste are required to sort the contents of the bags on site to ensure all recyclable materials are removed and placed in the correct containers. Sorting tables and boxes have been installed in front of the general waste bays at each site. However, we're most keen to encourage recycling to be sorted as much as possible before visiting.



There have also been changes to the amount of domestic building waste (rubble, soil, ceramics and plasterboard) that can be recycled free of charge at the recycling centres.

The <u>Department for Environment Food and Rural Affairs (DEFRA)</u> published updated legislation on this in December 2023. Our recycling centre policy now follows guidance from DEFRA, no more than the equivalent of two 50-litre bags of plasterboard, rubble, soil and ceramics is allowed to be disposed of in a single visit. The number of visits is also limited to four single visits per household in any four-week period. Residents who have waste in excess of these limits are encouraged to hire a skip or use a licenced waste removal company.



#### Did you know?

We now sell compost at the reuse shop at Keynsham Recycling Centre. It's produced locally from garden waste the council collects from homes in the district. The bags cost £4 for 40 litres of multipurpose compost. Further details can be found in this recent press release:
